

## AN ACT TO BE ENTITLED

AN ORDINANCE AMENDING ORDINANCE NO. 01-03 TO CHANGE THE NAME OF THE SADDLEBROOK VILLAGE COMMUNITY DEVELOPMENT DISTRICT TO THE SEVEN OAKS COMMUNITY DEVELOPMENT DISTRICT I PURSUANT TO CHAPTER 190, FLORIDA STATUTES; PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, on January 23, 2001 the Pasco County Board of County Commissioners (the County) adopted Ordinance No. 01-03 establishing the Saddlebrook Village Community Development District pursuant to Chapter 190, Florida Statutes; and,

WHEREAS, SB and Associates, Limited Partnership, d/b/a Crown Community Development (the Petitioner), has petitioned the County to adopt an ordinance renaming the Saddlebrook Village Community Development District (the District) to Seven Oaks Community Development District I pursuant to Chapter 190, Florida Statutes; and,

WHEREAS, the County finds that all statements contained in the Petition to Rename the District (the Petition) are true and correct; and,

WHEREAS, The Board of Supervisors of the CDD have provided authorization for the renaming of the District; and,

WHEREAS, the County finds that the proposed amendment is not inconsistent with any applicable element or portion of the State of Florida Comprehensive Plan or the Pasco County Comprehensive Plan; and,

WHEREAS, the County finds that the area of land within the District, as established by Ordinance No. 01-03, and as amended herein, remains the same, remains a sufficient size, and remains sufficiently contiguous to be developed as a functional interrelated community.

NOW, THEREFORE, BE IT ORDAINED by the Board of County Commissioners of Pasco County, Florida, as follows:

SECTION 1. RENAMING OF THE DISTRICT

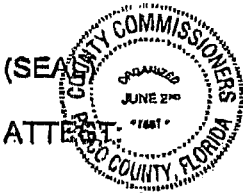
